### 2. Vendors' Eligibility Criteria

#### 1) Status of Vendor

The vendor should be dealing in signage board, Digital boards and other items as mentioned in above list and should have expertise in installation of same

#### 2) Financial status

Turnover of the bidder from preparation and installation of the boards should not be less than in India should not be less than Rs 15 lac (Fifteen Lac) during the last financial year (2022-2023). The balance sheet of the vendor should show profit during last 3 years.

Audited Balance Sheet (provisional, if not audited for 2023-2024) and Profit & Loss Account documents for the years 2020-21, 2021-22 and 2022-23 should be enclosed.

# 3) Reliability/Quality of the Hardware

Since the signage boards etc will be used at various place for display, hence the quality of the boards and other items should be good and should be such that bank visibility may be enhanced

**4)Validity of empanelment** –Empanelment is valid for 1 year from the date of empanelment and extendable for 1 more year subject to the satisfactory services and quality of boards etc supplied by the vendor

Guarantee/ warranty: The bidder must guarantee the equipment/ materials/ supplied against faulty design/ material/ components/ workmanship giving rise to replacements. The warranty should be valid for a prescribed period as per item from the date of handing over, irrespective of the date of deliveries. In the case of failure of the successful bidder to provide stipulated post installation/supply of items services or delay in supplying items ,bank reserves right to get it done by other agencies and adjust expenditure incurred in such work against pending bill of the vendor .Bank will charge penalty @5% of the cost of the items if the items quality is inferior or delay in supplying requisite items

# SPECIFICATION (GLOW SIGN BOARD) BASIS OF DESIGN

- (A). All signage covered under this specification shall be good for installation.
- (B) All signage, except where specified as indoor, shall be good for outdoor installation without any shade/cover/protection.
- (C) All illuminated signs shall be suitable for operation from dusk to dawn everyday throughout the year.
- (D) All outdoor signages should be designed to withstand all climatic conditions
- . (E) . LED lights of required wattage and numbers shall be placed in such a manner to achieve uniform lighting of the signage (min one LED light (4ft) size per 4 sqft area). It shall be ensured that no dark patches, hot spots, shadows and light leaks appear when the lights are turned on.
- (F) . The design of signage shall facilitate easy maintenance & re-lamping. The maintenance doors/panels should remain water/dust tight during normal usage. Electrical works The wires running inside the signage box shall not run/hung loose. The wires shall be taken inside the Conduit / PVC sleeve and all cable shall be saddle properly, which shall be properly supported. All wiring should be numbered with ferrules. ii. It shall be possible to maintain & replace, light fittings, chokes etc. inside the signage, without dismantling the signage by providing adequate space inside the signage and providing suitable removable entry/access doors/covers. All lighting work shall be completed in all respects even if not indicated and spread of light should be uniform. All the electrical equipment except lighting fixtures to be located inside the signage board shall be weatherproof and suitable for outdoor duty.

# **COLOURS**-- Colour of the signage shall comply with approved shades.

Vendor shall submit colour samples of vinyl film & paint to obtain clearance before proceeding with the art/painting work for all relevant signage

Warranty: • Contractor should provide a Comprehensive Warranty from the single source manufacturer of the translucent vinyl and the flexible substrate for a period of at least 5 years.

- . Warranty should be against: 1. Yellowing / Graying of Flex
- 2. Wicking of flex
- 3. Fungus or Mildew formation
- 4. Vinyl peel-off, fading, shrinkage, cracking and crazing
- The Authorized Contractor's final bills would be cleared only on submission of the duly endorsed Warranty Documents that fulfill all the above conditions.
