For Recruitment of Chartered Accountant in Officers' Grade/Scale-II (One)

The Nainital Bank Limited is around a century old Private Sector Scheduled Commercial Bank established in the year 1922 by Bharat Ratna Late Pt. Govind Ballabh Pant and few other prominent personalities of Nainital.

With a glorious track record as a profit making entity since 1973, Nainital Bank Limited is the only Scheduled Commercial Bank of Uttarakhand with 98.57% of its shareholding with Bank of Baroda, operating its Head Office from Nainital. At present the Bank has 03 Regional Offices one each at Haldwani, Dehradun and Noida with a network of 171 branches across 05 states of North India namely Uttarakhand, Uttar Pradesh, Delhi, Haryana and Rajasthan.

To fulfill its manpower requirement, Bank intends to recruit One Chartered Accountant in Officers' Grade/Scale-II in the IBA Pay Scale of Rs. 64820-2340/1-67160-2680/10-93960 (under revision at Industry level). CTC would be approx. Rs. 15.00 lacs per annum. The Bank, accordingly invites applications through Registered/ Speed Post from eligible candidates fulfilling the following eligibility criteria:

- 1. **Age-** Candidates should be in the age group of 25-40 years as on 30.06.2024.
- 2. **Professional Qualification-** The candidate should be Associate Chartered Accountant (ACA)/ Fellow Chartered Accountant (FCA) from Institute of Chartered Accountant of India (ICAI).
- 3. **Essential Experience** Minimum -2- years' Post Professional Qualification experience of working as CA in the units of Bank's, NBFC & FI's. Candidates having JAIIB/CAIIB certifications will be given preference.

Application Fee - Rs. 1,500.00 (Rupees one thousand five hundred only) including GST which should be remitted through Demand Draft in favour of 'Nainital Bank Limited' payable at Nainital and be attached with application.

- Copy of Certificates and Mark sheets in respect of educational and professional qualifications acquired.
- > Appropriate document(s) in support of post professional qualification experience.
